

A MESSAGE FROM THE PRESIDENT

Dear Colleague:

Our specialty has a strong and wondrous future. It has been my privilege in the past year to serve as AAP Foundation President during a time when that future revealed itself to be attainable.

In a year when ongoing economic uncertainty and a war with no easy resolution could have undermined our faith in the future, our membership chose instead to embrace the future with a spirit of optimism and generosity. Nowhere was this more evident than in the extraordinary response of individual donors to the "Challenge" campaign for the Gerald M. Bowers Endowment Fund for the American Board of Periodontology during the Annual Meeting in San Francisco. In a matter of days, individual members donated more than \$240,000 to the Fund, which now stands at \$1.24 million in pledges and gifts and \$380,500 in planned gifts, proving Dante's observation that "a great flame follows a little spark."

The AAP Foundation has the responsibility for both igniting the spark and seeing that the flame endures. It is this responsibility that illuminates the key role the Foundation plays in moving the specialty toward periodontology's 2020 Vision. In 2003 the Foundation expanded its support of areas targeted as critical to the specialty's future with the announcement of the two new awards at this year's Annual Meeting: the Richard J. Lazzara Fellowship in Advanced Implant Surgery and the E. Bud Tarrson Research Award in Oral Plastic Surgery. The \$50,000 Lazzara Fellowship will provide educational and clinical experiences reflecting the most current techniques in implant dentistry and the \$1,000 E. Bud Tarrson Award is given to the best paper on clinical oral plastic surgery published in a peer-reviewed journal. Both new awards align with the AAP 2020 Vision Statement, which sees the specialty as the leader in implants, periodontal medicine, and oral plastic surgery.

In addition, the Foundation provided a grant of \$100,000 to support the American Academy of Periodontology Workshop on Contemporary Science in Clinical Periodontics and also provided financial support to help produce a video, "Academic Careers in Dentistry," developed by the American Dental Education Association (ADEA). With these kinds of activities, plus a broadening array of awards and fellowships, the Foundation exerts a positive impact across the continuum of the periodontist's academic and professional life.

The Foundation does this thanks to the generous support of individuals and corporate partners, and it does it with remarkable foresight and economy. Charting a conservative investment approach has enabled the Foundation to endure a volatile market and continue to fund all programs. Moreover, the Foundation maintains a stringent operations budget, spending only 11.5 cents for every dollar raised. This means that 88 cents of every dollar raised goes to supporting programs key to the specialty.

Thank you for your support of programs vital to periodontology's 2020 Vision. By working together to ignite the "great flame" of today's vision, we ensure its reality tomorrow and for generations to come.

TWO NEW AWARDS ADDED IN 2003

Richard J. Lazzara Fellowship in Advanced Implant Surgery

The American Academy of Periodontology Foundation was proud to announce this new Fellowship, which supports a key area of practice for the future of periodontology, at the September 2003 Annual Meeting.

The Lazzara Fellowship is intended to support the American Academy of Periodontology's 2020 Vision—a shared and positive view of the future of the periodontal specialty. This vision is based on the following mission statement:

"Our specialty will be known for advancing oral health and well-being through expertise in implants, periodontal medicine, and oral plastic surgery."

This means that the specialty believes in the future:

- More periodontal practice time will be dedicated to advanced surgical procedures.
- Periodontists will be the first choice of referral for patients for these procedures.
- The number of self-referred patients for implants, oral plastic, and reconstructive procedures will increase.
- Periodontal specialty training programs of the future will focus on advanced surgical techniques and related biomedical science.
- Periodontists will continue to participate in research programs that yield new information regarding the successful use of dental implants.

This Fellowship is named in honor of one of the specialty's innovators in the field of implants and is funded with a \$250,000 commitment from 3i. Dr. Lazzara has published several articles and textbook

chapters on the subject of osseointegrated implants and is currently clinical associate professor at the University of Southern California School of Dentistry and associate clinical professor at the University of Maryland, Periodontal and Implant Regenerative Center.

Eligibility. Application for the Lazzara Fellowship is made jointly by a student in his/her third year of periodontal postdoctoral training in the United States and by the student's periodontal program director. The 12-month Fellowship will take place at the accredited institution where the candidate is completing his/her training.

Application Process. Completed applications must be received by the AAP Foundation by February 1. A committee appointed by the Foundation President will review the applications and select three finalists. The three finalists will receive complimentary air travel and hotel accommodations to enable them to attend a mandatory personal interview with the selection committee. The interviews will be held in Palm Beach Gardens, Florida, at a mutually convenient time.

The fellow will be selected by April 1. It is anticipated that the Fellowship will begin upon the fellow's completion of his/her periodontal training program.

Award. The \$50,000 award is payable to both the fellow and to his/her periodontal program. The fellow will receive a stipend of \$35,000, payable in July. The program will receive \$15,000, also payable in July, to offset overhead and administrative costs for the Fellowship.

E. Bud Tarrson Research Award in Oral Plastic Surgery

This award also was announced at the 2003 Annual Meeting. Its purpose is to support and encourage meaningful clinically-based research in oral plastic surgery. The American Academy of Periodontology defines "oral plastic surgery" as "refined surgical procedures of soft and hard tissue associated with the oral cavity performed to enhance esthetics and/or function." The award also honors the memory of E. Bud Tarrson, a much-beloved member of the AAP Foundation Board of Directors.

The award recipient will be announced in the fall of each year at the AAP Annual Meeting. The award includes a cash prize of \$1,000, to be shared among the authors. Each author will also receive a plaque.

The application deadline is July 1. The three-person selection committee appointed by the AAP Foundation President will evaluate the submitted articles to determine the one that makes the greatest contribution to the field of knowledge in oral plastic surgery. All articles must meet the following criteria:

- The article must have been published in a peer-reviewed scientific journal between July 1 of the previous year and June 30 of the current year.
- The article must apply directly to oral plastic surgery.
- The article must have been published in an English-language journal.
- Articles considered may be clinical trials, expanded case reports, or well-documented technique articles.

The article receiving the award will be one that directly benefits patients by enhancing the clinician's ability to treat potentially disfiguring or functionally compromised defects of soft tissue and/or bone. Topics may be as simple as esthetic crown lengthening, or as dramatic as distraction osteogenesis.

BOWERS ENDOWMENT FUND GAINS

The Gerald M. Bowers Endowment Fund for the American Board of Periodontology is a primary focus of the Foundation's fund-raising efforts. Launched in fall 2001 as a five-year, \$1.5 million campaign, the Fund stood at \$1,236,068.80 in pledges and gifts and \$380,500 in planned gifts by late 2003. Interest from the Endowment will be used to incorporate the latest testing technologies to meet the needs of a growing pool of applicants, and to stabilize the American Board's financial position now and in the future.

The Fund received significant boosts at the 2002 and 2003 Annual Meetings. At the 2002 meeting in New Orleans, Sonicare/Philips Oral Healthcare pledged \$250,000 and Straumann renewed its \$50,000 Foundation pledge with a pledge to the Bowers Fund. Individual donors pledged more than \$75,000 at the meeting.

At the 2003 Annual Meeting in San Francisco, Astra Tech committed \$50,000 to the Fund if AAP members donated \$150,000 during the meeting. When members exceeded the challenge by donating

nearly \$240,000, Astra Tech was so impressed they raised their own commitment to \$75,000.

Also in 2003, the Foundation launched "Place the Bowers Fund Over the Top," an innovative campaign involving patients, periodontists, and implant companies. Using implants provided free by corporate partners, periodontists donate their placement services to selected patients. Participating patients have the opportunity to express their appreciation by making a donation to the Foundation in honor of their periodontist.

AWARDS GRANTED IN 2002-2003

Through its awards programs, the American Academy of Periodontology Foundation supports the Academy's 2020 Vision, which acknowledges education and research as key areas of influence in determining the specialty's future. With the addition of the Richard J. Lazzara Fellowship in Advanced Implant Surgery, the Foundation further expanded support of the 2020 Vision, which includes as a goal periodontology as a premier provider of implants.

American Academy of Periodontology Student Scholarship

Established with a grant from the AAP to the Foundation, this scholarship awards \$5,000 to up to five outstanding dental students entering periodontal programs each year. Applicants must be in their final year of dental school and accepted to a postgraduate periodontal program in the United States. Criteria include academic merit, financial need, and community service. Winners of the past two years and the periodontal programs they attend are:

The Abram and Sylvia Chasens Teaching and Research Fellowship

Created in recognition of the need for periodontal educators, this award grants two \$15,000 Fellowships each year to periodontal postgraduate students who intend to pursue a full-time career in periodontal teaching and research. 
