There is a lot to look forward to in 2025, and this is just the beginning. I can't wait for all that is to come



Beyond the Practice-Between Two Teeth

Let's dive beyond the practice and learn more about Dr. Stephanie Ganter.

A year ago, we learned about Dr. Ganter's efforts on both an international and national level. We also learned that Dr. Ganter has her own podcast called Between Two Teeth which she cohosts with Dr. Bob McNeill. Periospectives reached out to Dr. Ganter to learn more about this podcast and what listeners can expect.



For those who don't know, can you share how you came up with the name of your podcast, Between Two Teeth?

Yes, I love this question! Have you ever seen the YouTube show Between Two Ferns with Zach Galifianakis? He will have actors and political figures on his show for an interview, using humor to shed light on some tricky topics.

I liked the show's set up using humor to assuage tricky situations and, of course, entertain viewers. We started with YouTube videos, then podcasts, and eventually much of our messaging on Instagram @B2Teeth. I like our content to be organic and meaningful.

How did you come up with the idea for this podcast? What inspired you and Dr. McNeill to start this journey?

I was on a motorcycle ride with my partner, Dr. Bob McNeill, an oral and maxillofacial surgeon in our multi-specialty private practice. Interestingly, we have the best conversations when riding motorcycles and do a lot of our best planning. On this particular ride we started toying with the idea of starting our own podcast, and the funny thing was we didn't want it to be about dentistry. I loved the idea because it was so different from our roles as surgeons - serious, detail oriented, referral based and patient centric. That is really the point of Between Two Teeth and us as well - to connect, discover and empower others. I've found that life can be fulfilling even when it is imperfect. In this light, I wanted to build bridges within our surgical specialties. Dr. McNeill's role as a regulator with the Texas State Board of Dental Examiners and mine, at the time, as a board member for my component society and the Texas Society of Periodontics gave us a unique opportunity to do so.

We have been fortunate to have been able to present at several national meetings with the American Association of Oral and Maxillofacial Surgeons and the American Dental Association. I've also been invited to speak at the 111th Annual Session with the American Academy of Periodontology in 2025. The meetings are critical for promoting a message of colleagues working better together.

What is the main message or takeaway you hope listeners get from each episode of Between Two Teeth?

I push a message of living life to the fullest, both inside and outside of the office. As an ADA Wellness Ambassador, I've learned how practitioner mental health is key to delivering the best care to our patients. When our listeners watch an episode of Between Two Teeth, I want them to challenge themselves, ask questions like 'how are you doing, really?', and of course laugh - there is healing in laughter. Through *Between Two Teeth*, I've been able to embark on unusual mission trip adventures that are reflected in our content. Viewers can watch Dr. McNeill and I ride through the Himalayas on



motorcycles stopping along the way at outreach dental clinics to distribute supplies and interact with public health doctors, like Drs. Dilep and Dash in Dhulikhel. Flip through some videos to catch us in Warsaw, Poland with ADA Trustee, Dr. Craig Armstrong and ADA Senior Director for Dental Practice Policy, Dr. Hana Alberti as part of our medical relief team providing care to war-displaced Ukrainian citizens. Take a trip with us to Thailand or Italy through our videos to see how culture and service intertwine to provide a different type of continuing education, well beyond the classroom setting.

What are some of the everyday life topics you've covered that surprised you with how they connected to dentistry or healthcare?

When we were interviewing the American Dental Association (ADA) past-president, Dr. George Shepley, he made the case for self-care by saying, "dentists need to put the oxygen on ourselves if we are going to best care for our patients". That will look like different things for different people. I've been surprised by our

viewer engagement to our simplest messages: stretching, spending time with friends, and traveling. We intentionally try to push boundaries and push others to find their own version of what they need to do to be their best version of themselves. I think our content reflects our commitment to those values.

Can you share a memorable moment or guest experience from the podcast that stands out for you?

My most memorable experience was onstage, as a host of the American Dental Association annual meeting where Bobby and I conducted a live interview with Hollywood actor Constance Wu. She shared her own well-being journey as a struggling actress, having great success with movies like *Crazy Rich Asians* and a hit TV comedy series *Fresh off the Boat*. She also related stories of harassment and mental health issues, including depression and suicidal ideation. It was impactful to hear her story and be able to provide a perspective that would be important for our colleagues, especially as a fellow woman.

Is there a life lesson or personal philosophy that comes up regularly on the podcast? How does it tie into your work as a periodontist?

As mentioned, I want our viewers to feel empowered to pursue a life best lived. I read an article yesterday talking about the hidden costs of things like Netflix, social media and fast food. I was lucky to realize early on in my career that money isn't the greatest cost. Our greatest cost

is our time and our health. When I approach choices I make through a lens of time and health, I'm empowered to make decisions that align more with my values. I decided during the pandemic I wanted to lead a value driven life building health and spending time wisely between my patients, my people and myself.

2025 Annual Meeting: Call for Innovations in Periodontics abstracts

The Continuing Education Oversight

Committee (CEOC) is soliciting presentations
that address advances in clinical
periodontics, basic sciences, or related
subjects for the Innovations in Periodontics
program for the 111th Annual Meeting to
be held Oct. 15 – 18, 2025 (Wednesday –
Saturday), in Toronto at the Metro Toronto
Convention Centre. These sessions will
consist of 15-minute presentations. A fiveminute question-and-answer period will
follow each lecture.

There will be four sessions offered:

Advances in Periodontics: These two sessions are intended to showcase clinical advances and/or translational research with direct application to patient care. The target speaker is anyone who has a validated innovation to share. Individual and team-based presentations are welcome for this session.

Rising Stars: This session is intended for speakers in practice for ten years or less following post-graduate training. The selected candidates will receive training to present their material in a brief live or virtual platform showcase.

Perio Open Mic: This session is a platform to present a pivotal concept, perspective, or paradigm-shifting philosophy. The target presenter is a midto late-career periodontal clinician or scientist with a validated innovation to showcase. Unlike Advances in Periodontics, this is the forum to present a philosophy, ideology, or thought, rather than a case presentation.

Individual presentation abstract submission procedure:

- Abstracts will be subjected to a blind review and scoring by members of the CEOC.
- Presenters will be informed of the committee's decision in spring 2025.
- Presenters can submit as many abstracts as they would like. However, no one can present more than once.

You will need to provide the following information about your presentation:

- The title, which should be ten words or fewer, and not include brand names or acronyms.
- Why this presentation is innovative.
- How your presentation impacts practicing periodontists.





- Which of the following topics it covers:
 - Emerging Concepts and Innovative Therapies
 - Implant Surgery and Prosthetic Rehabilitation
 - Interdisciplinary Therapy (ortho, endo, restorative)
 - Leadership, Personal and Practice Development
 - Oral Pathology, Oral Medicine and Oral Diagnosis
 - Periodontal and Systemic Interrelationships
 - Periodontal Plastic and Soft Tissue Surgery
 - Sedation and Anxiety Management
 - Tissue Engineering and Hard Tissue Reconstruction
 - Treatment of Periodontal Diseases and Peri-Implant Diseases

Team-based presentation abstract submission for Advances in Periodontics procedure:

- The team-based presentation will consist of presenting a case and then describing the treatment and rationale for therapy, or an etiopathogenetic mechanism or pathway.
- Teams are limited to two speakers.

Teams will need to submit one of the following cases:

- Periodontal-restorative dentate aesthetic
- Complex periodontal-restorative aesthetic implant
- Complex periodontal-orthodontic demonstrating Periodontally Accelerated Osteogenic Orthodontics (PAOO) or orthodontic site development for implants
- Correct aesthetic implant complication with interdisciplinary therapy

Interested parties should submit abstracts and cases for committee consideration by **Friday**, **Feb. 7**, **2025**, via the Abstract Manager website. General submission information and directions for accessing the site can be found at **perio.org/ce-meetings/ abstract-submissions/** or contact the Continuing Education department at **continuingeducation@perio.org** or 312-787-5518

Meet Dr. Mia L. Geisinger


During the Annual Meeting in San Diego,
Dr. Mia L. Geisinger became AAP President for
the 2024-2025 term. Dr. Geisinger brings to
the table a wealth of experience and a lifelong
commitment to advancing the field of periodontics.
Her dedication to education and innovation
makes her an inspiring leader for our community.
Periospectives interviewed Dr. Geisinger so our
members can discover more about her impressive
journey and vision for the future.

You've been involved with the Academy for many years now, and wear many hats as a periodontist, professor, speaker, author, and researcher. How have these experiences shaped your approach to leadership?

One of the things that makes every day interesting for me is the fact that I am able to experience so many different aspects of our profession and able to interact with periodontists and dental healthcare professionals with various backgrounds and expertise. I have been fortunate to be mentored and to learn from colleagues and I am grateful to have had the opportunity to serve our profession throughout my career in many different arenas and these things have allowed me to see many great leaders in action! In teaching, speaking, and clinical patient care, communication is key to optimal outcomes and getting buy-in from those with whom you interact—whether that is involving patients in maintaining good oral hygiene or making sure that students and coworkers are primed to make positive changes in their work environment. I believe that all of these experiences together have helped me to develop into a leader for all AAP members.

What initially drew you to periodontics, and how has your passion evolved over time?

When I entered dental school, I was a certified dental assistant and had worked part-time in an oral and maxillofacial surgery practice through my college years. Beginning my first-year classes, I already



knew that I loved surgery, but I also knew that I wanted the opportunity to build long-term relationships with my patients. I was able to work as a dental assistant for a periodontist, Dr. Fraya Karsh, between my first and second years in dental school. I loved how she was able to interact with her patients and other dental healthcare providers and I especially loved that as a periodontist, she was able to build back hard and soft tissues that disease had taken away. In dental school I was also able to do a deeper dive into the science and practice of periodontology and I was hooked! I still love that I can follow patients for years in my practice and that I am able to help them save their teeth for a lifetime. I also enjoy the evidence-based practice of periodontics that allows us as periodontists to stay on the cutting-edge of research and clinical practice.

As the new president, what are your primary goals for the Academy?

Our Academy is for our members and EVERY MEMBER MATTERS! We want the American Academy of Periodontology to be the home for every periodontist starting as student members through their retirement! We have created initiatives for members across the spectrum, including an inaugural resident retreat for rising third-year residents in summer 2025 and a reception honoring our AAP Life Active members. We also want to make sure that we are working to push the science of periodontology and implant dentistry and its clinical application forward. The AO/AAP consensus conference on peri-implant diseases and the subsequent papers that will come forward from that are exciting as is our upcoming collaboration with the Osteology Foundation, SEPA, and DGI on regenerative techniques. Lastly, we know that the periodontist is a leader in the



dental healthcare team, and we want to equip AAP member periodontists with tools to better communicate with all members of the healthcare team, including the dental hygiene study club modules and opportunities to allow periodontists to position themselves as leaders in their dental communities.

In your opinion, what are some of the biggest challenges facing periodontics today? How do you hope we can address these challenges?

Periodontists are busy, engaged, highly skilled healthcare professionals who care about their patients and their communities. Because of the prevalence of periodontal and peri-implant diseases and conditions, periodontists see patients with a variety of clinical presentations and many of these are chronic, progressive conditions. Therefore, early identification, treatment, and/or referral is critical to the long-term oral and overall health of the patient and the success of periodontal care. Through providing education and serving as a resource to all members of the dental community, the AAP and member periodontists can empower dental healthcare professionals and their patients to seek out periodontal care.

How do you plan to engage younger periodontists and new members of the Academy? What role do you think mentorship plays in the periodontal community?

As an educator, I know that young periodontists are the lifeblood of our profession. The AAP provides support for younger members of the Academy from before they are even accepted into a periodontal program through their sponsorship of the MATCH process and support for identifying programs that may be a good fit for applicants. As student members, educational resources like the AAP Hour

and Education Access modules enhance the educational experience during residency and in 2025 the AAP will host our inaugural AAP retreat for rising third year residents. The AAP also has engaged with over 120 young periodontists through its Leadership, Engagement, Action and Development (LEAD) program focusing on providing mentorship and sponsorship to rising stars in the periodontal community. The AAP has made a commitment to foster positive relationships with younger periodontists starting in residency and continuing throughout their careers!

You have an active social media presence. What is the importance of social media to you, and how do you use social media platforms to engage with other professionals?

Unlike the students and residents that I work with, I am not a technology native, but I like to find fun ways to connect with colleagues, friends, and members of the dental community through my social media (@miagdds). Social media can be a way to keep in touch with people across the globe and offers an opportunity to provide educational material and interesting facts about periodontology to dental healthcare professionals and patients!

Beginning with the first issue of the year, released in March of 2024, *Periospectives* received its largest update in look, feel, and content in over a decade. Those changes were just the beginning.


Digital Periospectives



The **Education Committee** recommended candidates for the next Education Consultant.


The **In-Service Examination Committee** started work on developing the 2025 In-Service Examination. ■



Help! How much disability income insurance should I carry if I also have employer group coverage through my work?

Shawn M Johnson, ChFC®, CLU®, CLTC Vice President, Business Development Treloar & Heisel. Inc. I get disability insurance through my employer. Do I even need to look at getting my own disability income insurance? If yes, why? How much do I need, and what kind?"

Have these questions been on your mind, too? We frequently get questions identical to this from doctors, many of whom work for a large employer, and who receive some form of disability insurance as part of their benefit package. I thought I'd sort out some common sources of confusion and address several of the top questions we receive about disability income insurance for doctors.

Isn't my disability insurance through work, the same thing as the disability insurance that I can get on my own?

First, I don't know what kind of insurance your employer offers. However, I'd say don't mistake your employer disability coverage with individual disability income coverage. The first thing that confuses almost everyone has to do with terminology: your employer most likely offers a kind of disability insurance called Long Term Disability coverage (or "LTD" for short). Unfortunately, this is often simply called "disability insurance" which is what confuses people when they realize you can also buy individual disability income insurance (called "DI" or "IDI" for short).

LTD is a benefit that is purchased at the group level by employers for the employees of that organization. Basically, it offers employees access to long term disability benefits should you have a need for income protection while you are an employee at your current place of employment.

IDI on the other hand, is sold to individuals — physicians, dentists, or other professionals, and while group long term disability insurance may be offered as an employee benefit, IDI may have much more robust benefits.

What's better? My employer group disability policy, or the one I buy myself?

Ultimately, it's impossible for anyone to say whether the specific LTD policy that your employer offers is suitable, good/bad, or to qualify it in any way. One would have to read the contract to get a good sense of what it covers.

But one thing to consider about employer-provided group long term disability policies is that often it is not portable. In other words, if you change employment, you may not be able to take the coverage with you.

Another thing to determine about your employer-provided group long term disability is if the premiums for the coverage are being deducted or paid with pre-tax dollars by your employer. You should consult your tax advisor, but often if the premiums have been deducted, any benefits you could receive while disabled could be taxable. That, of course, would translate to a reduction in the actual benefit amount you receive.

Here are the advantages of buying your own individual disability income policy:

1. It's yours to keep, as long as you pay your premiums, up to the contract period (often age 65).

One of the things you need to keep in mind is that individual disability income insurance is priced based on your age and health. The younger (and presumably healthier) you are, the more affordable it is, so there's never a better time to get it than now.

- 2. You get to customize it to meet your needs, so you have much more control over its design, how much benefit you need, and many other policy features (called riders) like inflation protection, the ability to increase coverage without medical underwriting, and more.
- 3. It can "grow" with you as your career and income grows.
- 4. If you pay your premiums with after-tax dollars, your benefit should be tax free to you. *

One of the things you need to keep in mind is that individual disability income insurance is priced based on your age and health. The younger (and presumably healthier) you are, the more affordable it is, so there's never a better time to get it than now. This is why we encourage doctors to buy individual disability income while they are still in residency or at the beginning of their professional career. Even a small policy you secure as a resident can be expanded as your career evolves. Once you buy it, you can "lock in" discounts and look to enhance the coverage in the future. If you decide not to buy, and then experience some health changes, you may find it difficult to gualify for this insurance later in your career.

Should I opt out of employer-provided disability insurance?

No, to the contrary. If your employer is providing you a good benefit at no cost or a very affordable price, you should consider taking advantage of it. We also believe that it makes sense to have a foundation of individual disability income coverage as your primary income protection and treat the group employer coverage as a supplemental tool. This way, you have peace of mind that you are covered, even if you change your place of employment, and your employer-provided insurance may enhance or potentially fill a gap in coverage.

It is important to note that employer-provided Long Term Disability Insurance may have a number of disadvantages, thus making it better suited to supplementing an individual disability insurance policy:

- 1. You may not have portability with a group long-term disability plan.
- 2. The insurance company typically can make changes to the plan at any time.
- 3. Your employer could change the plan or eliminate the plan.

OK, so now can you answer how much individual IDI I can buy, given that my employer also offers disability insurance?

It really depends. Doctors who apply for IDI are often surprised as to how much individual coverage they can obtain. "Replacement limits" (meaning how much of your income you can "replace" with individual, and group LTD coverage combined) are always changing, but at the time of this writing (and in our experience to date) these ratios are fairly liberal. It's worth checking out for sure.

If I do decide to buy individual IDI as my "base policy" where should I begin?

As I mentioned, the industry is constantly changing, but you're curious as to what is available to you, ask your insurance advisor. Hopefully you are working with an advisor who is experienced with the needs of physicians and dentists, so that they can give you the kind of guidance you need. Your advisor should be able to look at what's available to you in the insurance market for individual disability income insurance, and coordinate that with your employer provided group coverage. To get a better grasp on what's in your employer-provided group policy, contact your HR or benefits department and request a copy of your policy documents.

Final words of advice

Before you go, I want to leave you with this summary. Are you "all set" if you only have employer-provided DI? I'd say probably not. Even if you have underlying group coverage, it may not be portable, it may not be enough coverage, and it may or may not be taxable to you. That's a lot of unknowns.

On the other hand, it doesn't hurt to look into an individual disability income insurance policy, or to have your existing policy reviewed by an insurance advisor. A competent and experienced professional should be able to read your policy documents and point out any potential gaps. Best case scenario, you'll identify an opportunity to augment your individual coverage, which is only to your advantage.

Most people think that a disability is not something that will happen to them, but our experience is that it happens more than you know. The power to protect your income in the face of illness or prolonged absence from the workforce is well worth the small amount of effort it takes to investigate this matter. Ask the Coding Coach

Every Jan. 1, any changes to the CDT codes made by the American Dental Association's Code Maintenance Committee become effective. There were no changes made to the Periodontics category this year, but there have been changes in other areas that a periodontal office will be using on a regular basis.

In the Implant Services category, there have been several changes. Through an addition and a revision, maintenance of hybrid protheses is more specific as to what type of procedure is being performed. One is used when the prothesis is removed; the other when the prothesis is not removed. The procedure becomes more involved when removal and reseating the hybrid as well as cleansing the exposed implants. Distinguishing between these two will better describe the procedure being performed.

Implant Services

The following code is a new addition:

D6190 Implant maintenance procedures when a full arch fixed **hybrid** prothesis is not removed, including cleansing of the prosthesis and abutments.

This procedure includes active debriding of the implant(s) and prothesis. The patient is also instructed in thorough daily maintenance of the implant(s).

The following code is a revision of the existing code:

D6080 implant maintenance procedures when a full arch fixed **hybrid** prosthesis is removed and reinserted, including cleansing of the prosthesis and abutments.

This procedure includes active debriding of the implant(s) and examination of all aspects of the implant system(s), including the occlusion and stability of the superstructure. The patient is also instructed in thorough daily cleansing of the implant(s).

Also in the Implant Services category, there is one other addition and several revisions.

The following code is a new addition:

D6193 replacement of an implant screw.

The following codes are revisions of existing codes:

D6011 surgical access to an implant body (second stage implant surgery)

This procedure, also known as second stage implant surgery, involves removal of tissue that covers the implant body so that a fixture of any type can be placed.

D6081 scaling and debridement of a single implant in the presence of mucositis, including inflammation, bleeding upon probing and increased pocket depths includes cleaning of the implant surfaces, without flap entry and closure.

This procedure is not performed in conjunction with D1110, D4910, or D4346

D6090 repair of implant/ abutment supported prosthesis.

Also, code **D6095** repair implant abutment, by report, was removed from the code set.

Oral and Maxillofacial Surgery

The Oral and Maxillofacial Surgery category also has changes to note. The AAP submitted a request for a new code which describes the partial extraction technique for implant placement. It was accepted but was placed in the oral surgery category as a new code. A second addition is a code for nerve dissection.

The following codes are new additions:

D7252 partial extraction for immediate implant placement

Sectioning the root of a tooth vertically, then extracting the palatal portion of the root. The buccal section of the root is retained to stabilize the buccal plate prior to immediate implant placement. Also known as the Socket Shield Technique.

D7259 nerve dissection

Involves the separation or isolation of a nerve from surrounding tissues. Performed to gain access to and protect nerves during surgical procedures.



There are other codes changes in various categories that you need to be aware of. These include:

Restorative

The following code is a revision of the existing code:

D2940 placement of interim direct restoration

Direct placement of restorative material to protect tooth and/or tissue form. This procedure may be used to relieve pain, promote healing, manage caries, create a seal for endodontic isolation, or prevent further deterioration until definitive treatment can be rendered. Not to be used for endodontic access closure, or as a base or liner under restoration.

Adjunctive General Services

The following codes are new additions:

D9913 administration of neuromodulators

D9914 administration of dermal fillers

Sleep Apnea Services

The following code is a new addition:

D9959 unspecified sleep apnea services procedure, by report

"Sleep related breathing disorders" was also added to the descriptor for **D0160** detailed and extensive oral evaluation – problem focused, by report.

It is important to be familiar with changes to CDT, and it's highly recommended to buy the *CDT 2025* book as well as the *Coding Companion*, published by the ADA. The *Coding Companion* has excellent scenarios and FAQs to help ensure correct coding. The AAP's Third-Party Specialist is also available to answer any questions you might have.



Norton M. Ross Award for Excellence in Clinical Research Recipient- Dr. Yvonne L. Hernandez-Kapila



Advocating for Perio

Learn more about whose advocating on your behalf from **Drs. Leigh Kent** and **Jessica Stilley** who serve in various volunteer roles with the American Dental Association (ADA).

Dr. Leigh Kent

What positions, past and present, do you hold on to the various ADA Councils, Committees, and Commissions? How do these roles benefit the dental profession?

I am presently serving as Chair of the Council on Government Affairs (CGA). This is my fourth year on this Council. In addition, I am presently the Chair of the State Public Affairs (SPA) oversight workgroup, a liaison to American Dental Political Action Committee (ADPAC), as well as serving on the Employee Retirement Income Security Act (ERISA) Task Force along with Dr. Stilley. I also served four years on the Council on Dental Practice (CDP). Advocacy is essential for the rights of patients and dentists as well as advancing the field, improving outcomes and accessibility.

What does advocacy mean to you?

Advocacy is promoting policies that stand up for patient rights and fair treatment for dentists. As different pressures are placed on our profession, advocacy allows us to rapidly respond as well as be a resource to educate state and federal legislators and agencies. This gives us voice and representation for present issues such as dental insurance reform, workforce shortages and student debt. It has also meant prevention of ineffective policies and laws from going into effect in the past such as prevention of the elimination of the cash method of accounting which allowed dentists to continue paying taxes on revenue they receive, versus what they bill to patients.

In addition to your ADA involvement, are there any local initiatives you participate in to advocate on behalf of periodontics?

Locally, I chair my own state's Task Force on Insurance Reform. This benefits patients in maximizing their premiums for the care as well as helping all dentists better care for their patients.

What tools do you use when advocating on behalf of periodontics?

There are many tools available for periodontists to use including serving as state and ADA leaders, being on organized dentistry's coalition calls, signing on to letters, contributing to ADPAC, sending periodontists to Lobby Day and responding to Action Alerts. These are good tools to improve our voice through better unity and collaboration.

Dr. Jessica Stilley

What positions, past and present, do you hold on to the various ADA Councils, Committees, and Commissions? How do these roles benefit the dental profession?

I served as a member of the council for dental benefit programs (CDBP) from 2019 to 2023, and I was Vice Chair from 2021 to 2022 and chair from 2022 to 2023. I was also a member of the Code Maintenance Committee from 2019 to 2023 and Chair of that committee 2023. I now serve with Dr Kent on the ERISA task force, and I am a member of the DeCC which is the Dental Content Committee. These roles are pertinent to the third-party payor landscape and how insurance companies work with practitioners.

What does advocacy mean to you?

Advocacy to me means protecting and preserving the profession of dentistry in a manner that upholds our standards but also opens conversations to allow for changes in technology and practice modalities. Dentistry continues to grow and change. Our advocacy efforts allow us to embrace these changes in ways that still protect our patients with solid standards of care.

In addition to your ADA involvement, are there any local initiatives you participate in to advocate on behalf of periodontics?

Locally I am a legislative contact dentist for a Florida State senator. This allows me one on one contact with a legislator to discuss topics that affect dentistry as well as periodontics. It really helps having a voice to shape policy at the state level.

What tools do you use when advocating on behalf of periodontics?


When advocating specifically for perio I focus on what makes our specialty different. Many times there is not an understanding of what a periodontist is and how we fit into patient care. Highlighting the importance of how periodontal disease fits into a patient's overall systemic health can be eye opening to a law maker.

Without the Academy's collaboration with international organizations, the 110th Annual Meeting would not have been possible. This year's Annual Meeting was held in collaboration with the Japanese Society of Periodontology (JSP) and the Japanese Academy of Clinical Periodontology (JACP). 



CAP Moving to Online-Only Format in 2025

Next year, *Clinical Advances in Periodontics* will transition from a print + online journal to online-only. With a growing number of readers accessing the online version of CAP and downloading articles, the Academy and its publisher, Wiley, agreed it's an appropriate time to make this transition. This change in format also reflects the original vision for CAP when it first launched as a digital journal in 2011.

For AAP members, there are numerous advantages to CAP being online-only:

- Robust search and navigation tools to find specific content
- Access to archived issues going back to 2011

During the COVID pandemic, disruptions to printing and distribution accelerated the move to online-only for hundreds of scholarly journals, and this trend continues today. In addition to the benefits above, online-only publishing allows publishers and associations to publish more content because there are no editorial page limitations.

Members do not need to do anything on their part. This change will become effective with the March 2025 issue. ■

New Model Legislation Developed by ASDA, AAOMS, and AAP

In partnership with the American Society of Dentist Anesthesiologists (ASDA) and American Association of Oral and Maxillofacial Surgeons (AAOMS), the AAP has developed model legislation for sedation and general anesthesia that will serve as a template to be used as a framework for legislators and regulatory agencies to develop fair and safe laws to provide oversight to sedation and general anesthesia being provided in dental facilities. "It was important for the AAP to bring the voice of the periodontists, leaders in providing moderate sedation, to this unique collaboration with ASDA and AAOMS," said James Spivey, DDS, MS, former District 1 Trustee and former Board liaison to the AAP Anesthesia Committee.

The model legislation was developed after reviewing multiple state sedation and general anesthesia regulations, utilizing best practices from states to achieve one consensus document that can be used as a blueprint to guide state dental boards and regulatory bodies in regulating how general anesthesia and sedation are practiced within dentistry. State dental boards have long requested such a template, as creating a comprehensive outline which encompasses all of the different facets of sedation and anesthesia practice in dental offices is incredibly challenging.

OLD POLICY

"The collaborative model legislative document co-drafted by ASDA, AAOMS, and AAP is uniquely positioned to give guidance to stakeholder groups. This document protects not only our patients but also our right to provide sedation and anesthesia in our practices now and in the future," explained Tyler Borg, DDS, MS, chair of the AAP Anesthesia Committee.

The field of periodontology has always been a leader in scientific discovery in dentistry and oral health. Continued research and clinical applications in biologics, biomaterials, and enhanced surgical techniques is



expected, along with more integration of artificial intelligence and digital workflows in periodontal practices. Considering the numerous established associations of periodontal disease with systemic conditions, periodontists are best positioned to embrace concepts like P4 medicine (prediction, prevention, personalization, and participation) for patient management and advocate for disease prevention and saving teeth.

Please tell us about your work on the ABP's Continuing Certification Committee and share your thoughts on the ABP's new continuing certification platform, ABPerio Minute.


I have had the privilege of serving on the ABP's Continuing Certification Committee as the ABPerio Minute platform was being developed. Through this innovative and user-friendly platform, the specialty of periodontology once again leads the way in dentistry and introduces a platform that truly supports lifelong learning for Diplomates through a continuous and longitudinal assessment. It has been a very exciting process to discuss the details of this new platform,

participate in its beta testing, policy development, question reviews, and most importantly to appreciate the overwhelming positive feedback generated by those who have experienced its ease of use and adaptability.

Do you have any advice for those considering pursuing Board certification?

While pursuing Board certification should be an organic process for new graduates, I have met several periodontists who successfully challenged the certification after years of practice. Common characteristics to all Diplomates irrespective of when they challenged the board include appropriate content preparation and organization of thoughts. In reality, the certification exam is designed to offer the opportunity to candidates to demonstrate their knowledge of fundamental concepts in periodontology and implant surgery. Those who are able to succinctly and clearly articulate their best evidence-supported thoughts in the identification and management of periodontal diseases and conditions and implant surgery should have no problems passing the certification exams.

2025 ABP ANNUAL REGISTRATION IS OPEN

The American Board of Periodontology 2025 annual registration is now open. There is no increase in the annual registration fee, which remains steady at \$325. The Board works diligently to manage expenses while also providing quality services to Diplomates. Diplomates are asked to complete the annual registration process by Jan. 15, 2025.



Following successful beta testing in 2024, full rollout of the ABP's

new continuous certification platform, ABPerio Minute, will take place in Jan. 2025. Diplomates will be able to keep their knowledge up to date using a cloud-based platform accessible via any device. The requirement will be to answer 15 multiple choice questions each quarter annually to maintain certification. ABPerio Minute replaces the current maintenance of certification exam every six years. The platform is designed to capture "walking around knowledge" so no preparatory study is necessary and there is no pass/fail. Questions are tailored to clinical practice and each question is timed to be answered in one minute. Citations for further self-study are provided for each question. Information about account activation and specific compliance requirements during the rollout period will be sent to Diplomates in the coming weeks.

DIPLOMATES DUE TO RECERTIFY IN 2024

Diplomates recertifying in 2024 are required to complete 60 ABPerio Minute questions by Dec. 31, 2024. ABPerio Minute is part of a triad of maintenance of certification requirements (MOC). along with the annual registration process and completion of 60 continuing education (CE) points over the course of the six-year certification cycle.
