

"Dental hygienists are primary health care providers. Although the standards of practice are slightly different from coast to coast, dental hygienists are taking a leading role in assessing the periodontal health and disease of their patients. Dental hygienists use periodontal probes to assess the depth of the pocket, determine the clinical attachment level, and diagnose the appropriate periodontal classification based upon the 2017 Classification of Periodontal and Peri-Implant Diseases and Conditions.

In many provinces and territories, dental hygienists make the independent decision to prescribe and take radiographs to assist in the diagnosis of the classification. The majority of dental hygienists in Canada graduate from educational programs that have met accreditation standards as set out by the Commission on Dental Accreditation of Canada (CDAC). Dental hygienists are implementing non-surgical periodontal therapy with their patients as well as educating them about their oral health and interventions, self and professional, to improve their oral, and subsequently, their overall health.

The amazing advocacy by staff of the Canadian Dental Hygienists Association (CDHA) and by CDHA's board of directors, who have continuously met with politicians from all political parties, senators, and key policy officials. Every politician has a dental hygienist. CDHA advocated for increased access to oral health care and was a key contributor in ensuring that the Canadian Dental Care Plan would come to fruition for all ages as of May 2025. Cost is an enormous barrier to professional oral care for many Canadians, and hopefully, by having an opportunity to seek out affordable preventive dental hygiene treatments, they will reduce their risks of experiencing oral disease.

I believe there has always been collaboration between dental hygienists and periodontists in Canada. Dental hygienists are regularly employed by periodontists and often spend the majority of their career with the periodontist. Certainly, periodontology is the dental specialty that most values the role of the dental hygienist.

It is exciting for dental hygienists to be able to attend this event in Canada! I do believe there is a benefit in having collaborative events with all members of the oral health care team attending, learning with each other, and learning about each other. In 2010 I attended AAP events held in Vancouver and in Honolulu. I was so impressed with the inclusiveness and value placed upon

the dental hygienist as an integral member of the oral health care team.

In 2019, the World Health Organization reported that 24.7% of the population in Canada, 15 years of age and over, had severe periodontal disease.1 That same year, the total productivity losses due to five oral diseases were more than \$6.5million (US).² The five oral diseases were caries, periodontal diseases, edentulism. oral cancer, and noma.3 Going forward, we need to realize that we are all managing disease. I attended EuroPerio11 in Vienna, Austria, in May 2025. An important take-home message for me was providing patients and the public with appropriate therapies to manage periodontal disease so that they can enjoy life, living longer and better."

2025 AAP Annual Meeting Speaker Profiles



Dallas-based periodontist Dr. Stephanie Ganter brings more than just professional insights to this year's Annual Meeting session FCE2: Obstacles or Opportunities: Resilience Makes the Difference. Speaking alongside Dr. Sharon R. Bannister and ADA President Dr. Brett Kessler, Dr. Ganter will bring her lived experience and explore how mental, emotional, and professional challenges can become powerful opportunities for growth.

"We're going to be talking about overcoming obstacles and why resilience matters. For me anecdotally in residency, that's when I really needed to start learning about resilience. There are all kinds of challenges, both emotional and mental health wise, that come up."

Her perspective on overcoming challenges is deeply connected to her values, which extend beyond the clinic. In addition to her private practice, Dr. Ganter is deeply committed to humanitarian work. She has helped locals through Texas Mission of Mercy and been on mission trips to Guatemala, Nepal, and Ukraine. "Mission work is about compassion. I studied for several years to become a periodontist.

All that bookwork, all those hours spent reading article after article, and none of it prepares you to connect and reconnect with the compassionate side of dentistry. That's what mission work does for me. I've enjoyed my time working at home through Texas Mission of Mercy and abroad through international mission trips. I just got back from Nepal—great people in Kathmandu Medical Center, and my mission trips to Ukraine and Guatemala. **Magic happens when you take a step outside of your comfort zone.**"

Dr. Ganter also advocates for intentional work-life balance. For colleagues seeking balance in a demanding career, she offers a thoughtful approach: "Some say balance cannot exist. I like to think you can achieve balance with some intentionality. I admire leaders like Dr. Mia Geisinger, our AAP President, who I feel can match her passions and her practice and balance it all. Prioritizing what fulfills you, perhaps by making a values list, can definitely get you started on how to delegate your time... Also, I've learned setting healthy boundaries in your practice life and personal life can really help you set the stage for balancing everything that you want to do in life."

And for the next generation of periodontists and dental students? Her advice is clear and empowering: "Stay curious, find mentors, and remember, it is a journey, not a sprint."

Looking forward to the meeting, Dr. Ganter encourages attendees to bring colleagues from other specialties as well. "I'm bringing an oral surgeon: my partner Dr. Bob McNeil. Together, we can learn from each other and achieve so much more."







Peter C. Fritz, DDS, PhD, MBA, BSc, FRCD(C), LLM

As artificial intelligence becomes more integrated into clinical practice, Dr. Peter Fritz is demonstrating how these tools can enhance efficiency and patient outcomes in periodontics. Dr. Fritz is a practicing periodontist, researcher, and educator based in Ontario, and will share his expertise during two sessions at this year's AAP Annual Meeting: GS3: Say Hi to Al: Deep Learning Applications in Periodontics and FCF11: The Art of Patient Care Beyond the Chair.

"We've been using AI in our periodontal practice for the past two and a half years," Dr. Fritz explains. "We've done a lot of deep learning ourselves. In Say Hi to Al: Deep Learning Applications in Periodontics, you're going to discover what works, what doesn't work, and how to optimize your practice to become more efficient."

Dr. Fritz's interdisciplinary background — which involves periodontics, surgery, innovation law, and technology — has shaped his unique approach to both clinical care and education. As an Adjunct Professor at McMaster University and Adjunct Professor at Brock University, he encourages cross-disciplinary learning to drive innovation in periodontics.

"I believe you have to visit different ecosystems in different sectors, gather information that isn't typically in dentistry, and then bring this back to your patch so that you can innovate the collaborative specialty of periodontics and redefine the patient experience which is what it's all about," he says.

His second session, The Art of Patient Care Beyond the Chair, offers a look at how his practice is extending care through technology. "I'm really excited to show you what we're doing in our clinic to deliver impact to our patients after they've left the chair: things like Al-generated brochures and treatment plans and follow-up messages generated with Al technology."

With a strong belief in lifelong learning, Dr. Fritz lives by the motto, "Never stop learning because the world around you never stops teaching." He shares advice for periodontists and dental professionals looking to stay ahead in this evolving field, encouraging embracing change and collaboration. "As dental professionals, we are built to learn and adapt. However, gaining inspiration from other clinicians from all over the world when they assemble at meetings like the American Academy of Periodontology is very powerful and it creates an impact that may shape the future of your practice."

Looking ahead to Toronto, Dr. Fritz emphasizes the value of in-person connection: "Society is shaped by relationships and information, and there's no better way to cultivate relationships and trade reliable, cutting-edge information than at the AAP Annual Meeting in Toronto. Come, join me—we're going to celebrate the energy, celebrate being periodontists, and how we can create more happy people in the world!"

Dr. Ganter and Dr. Fritz's stories are just a glimpse of what's to come in Toronto. This year's speakers reflect the dynamic spirit of the AAP community. We look forward to welcoming you to the 111th AAP Annual Meeting which will be filled with discovery, collaboration, and a celebration of what it means to be a periodontist!

What is your involvement with the ADA?

I am president of the Maine Dental
Association and District 1 representative
and vice chair-elect of the ADA New Dentist
Committee. I chair multiple state and regional
committees in these roles and act as our
district whip at the ADA House of Delegates.
I also serve on the ADA Future of Dentistry
Study and the Election Commission and
Campaign Rules for Elective Office Task
Forces. This past March, I chaired the
inaugural Elevate Leadership Conference in
Washington, DC. I have been a consultant to
the ADA Council on Membership and Council
on Advocacy for Access and Prevention.

What prompted you to extend your involvement beyond the AAP to the ADA?

I "grew up" in organized dentistry, attending ADA meetings with my family, as my dad moved through the chairs of our state association. In dental school, I served on the ASDA Board of Trustees as editor-in-chief. So, in many ways, I have come full circle. I joined the ADA to better understand current trends and challenges then got involved to help solve them. As a newer periodontist, it has been a meaningful way to bring our specialty into wider conversations about dental practice, education, and advocacy.

What do you personally get out of your active involvement with the ADA?

The ADA has been a powerful catalyst for my personal and professional growth. I've had the privilege of providing testimony on state legislation, co-creating ADA policies, and developing financial resources and leadership programs for students and new dentists. But it's the mentorship I've both received and paid forward that has been the most rewarding. I've learned from clinical experts, academicians, scientists, and industry leaders ways to break down complex problems and respond thoughtfully and with compassion. They deepened my sense of purpose as a clinician, leader, editor, educator, and business owner. Today, helping students, residents, and early career dentists discover their voice and place in leadership not only strengthens the future of our profession but constantly renews my own commitment to serve, advocate, and evolve.

What should AAP members know about the important work you and other AAP members are doing for the ADA, and why does it matter?

Our presence in the ADA ensures that we are centrally involved in oral health policy, education, and clinical standards that frame periodontal and implant care. We are advocating for stronger interdisciplinary collaboration, highlighting the oral-systemic connection— a link that is being questioned by changing politic interests. When we participate in policy development, strategic planning, and resource creation, we position the AAP as an essential partner in comprehensive patient care. FOR YOUR PRACTICE

Your income, inflation, and practice values have all gone up. How is your life insurance keeping up?

If you are a partner in private practice, you may have noticed that practice values have gone up dramatically in recent years. This is because private equity firms have entered the dental and medical space and have started acquiring practices, thereby driving up prices.

If you're like most dentists and physicians, you likely incurred a substantial amount of debt to fund your education. Upon graduation, that debt trend shifted (or will shift, if you're still in training!) as you begin to make money. At some point, you will be able to save money toward future goals. You may purchase your home, perhaps you will start a family and choose to provide opportunities for your children. All of this is possible.

How will your family continue living the way you envisioned?

When all this growth is happening in your life, it's easy to ignore the potential risks that could get in the way of your vision for the future. From a life insurance perspective many of you are woefully underinsured. Basically, this means that if you were to unexpectedly pass away, your family would not be able to maintain the lifestyle to which they have become accustomed based on your income.

A significant portion of the population is underinsured.

According to research conducted by the Life Insurance Marketing and Research Association *(LIMRA)* and *Life Happens*, "Overall, 52% of American adults report owning life insurance, and 41% of adults — both insured and uninsured — say they don't have sufficient life insurance coverage."





As a dentist or physician, and it's possible that you, too, may be among the 41% of the American population that doesn't have sufficient life insurance coverage. For example, unless there are significant additional assets, a specialist earning say \$400,000-500,000 a year may not be appropriately covered with just \$2 million of life insurance.

Whether you make more or less than this in annual income is not the question. The point is: when was the last time you sat down to calculate how much insurance you truly need? People tend to buy life insurance in their thirties when they are thinking of having or starting a family. Many never go back to revise that amount as their family grows, or as their income grows.

Private equity has driven up the price of practices.

If you are a partner in private practice, you may have noticed that practice values have gone up dramatically in recent years. This is because private equity firms have entered the dental and medical space and have started acquiring practices, thereby driving up prices. If you were to have a valuation done on your practice, and it showed an increase in value, that should propel you to increase your life insurance coverage to adequately fund your buy-sell agreement.

Other things that have been trending upwards in the past few years are incomes — which ties into another upward trending factor, namely inflation. Rising inflation means that the cost of everything is going up, and with it naturally the replacement cost of everything in your life is going up. Your life insurance policies need to be updated to reflect these increases in price.

How do you know how much life insurance you need?

The simplest answer is that your life insurance need is the amount of money your family will need in the future to live minus the assets (including retirement plans) and life insurance you currently have. This will give you a ballpark number. If you work with a financial professional, they will ask you how much you're saving, how much taxes you're paying, what assets you have and how they are invested. That will give you a more accurate picture.

Typically, we do not include your home as an asset in these calculations because if you pass away, your family will still need a place to live and will likely incur costs associated with this expense. Anyway, you do the math, and you will probably realize that you are underinsured.

Review your existing life insurance coverage with an experienced professional

The best gift you can give yourself and your loved ones is to set up a meeting with an insurance professional to accurately calculate your life insurance need. The best place to begin is to figure out how much life insurance you truly need. Once you know that, you can move to the next step of determining how best to fill your insurance coverage gap.

Ask the Coding Coach

Over the last several months, osseous surgery and regeneration procedures involving both natural teeth and implants in the same area of the mouth has been a recurring problem. Let's use an example: osseous surgery is completed in four quadrants, with only the third molars missing, as well as implants present in the areas of teeth #13, #29, and #30. Bone grafting using resorbable membranes was completed on tooth #14, and the implants for #13 and #30. Biologic material was used on tooth #14.

In most instances, the osseous surgery code is used correctly, D4260 x4. The codes for regeneration, however, are where the problems occur. In this case, the maxillary left quadrant should be coded as follows:

ULQ D4260 osseous surgery four or more contiguous natural teeth

#14 D4263 bone replacement graft -retained natural tooth -first site in quadrant

#14 D4265 biologic materials to aid in regeneration **#14 D4266** guided tissue regeneration, natural teeth, resorbable

Also, for this quadrant:

#13 D6102 debridement and osseous contouring of a peri-implant defect surrounding a single implant

#13 D6103 bone graft for repair of peri-implant defect **#13 D6106** guided tissue regeneration, resorbable, per implant

The mandibular right would be coded as follows:

LRQ D4260 osseous surgery, four or more contiguous natural teeth

#29 D6102 debridement and osseous contouring of a peri-implant defect surrounding a single implant

#29 D6103 bone graft for repair of peri-implant defect

#29 D6106 guided tissue regeneration, resorbable, per implant

#30 D6102 debridement and osseous contouring of a peri-implant defect surrounding a single implant

#30 D6103 bone graft for repair of peri-implant defect **#30 D6106** guided tissue regeneration, resorbable, per implant

The mistake occurs when it is assumed that the treatment performed will be covered by the codes for natural teeth. In these cases, although it may seem redundant, each implant must be coded individually for each procedure. It does not matter if the implants are adjacent or not since the coding is per implant. When this is not done, claims can be denied, or benefits may be reduced. It is important to remember, however, that plan limitations may also affect reimbursement. As with any claim, obtaining a pre-treatment estimate will avoid problems with both the carrier and patient.

Q: There are times when I am exposing an implant for restorative treatment and placing the abutment, and I then decide that an apically positioned flap will preserve attached tissue on the facial of the implant. How would I code for these procedures?

We always say code for what you do. The easiest way to determine if you are coding correctly is to look at the procedures you have performed in the order in which they are completed. In your case, the implant was exposed first. In most cases, this is accomplished with either a punch-type procedure or small partially elevated flap. D6011, surgical access to an implant body (second stage implant surgery), would describe this. Since you are placing the abutment, this second step would be coded for either D6056, prefabricated abutment, or D6057, custom fabricated abutment.

The last procedure was to elevate a flap (or further elevate the small partial flap from when you exposed the implant) and position it apically to provide keratinized tissue on the facial of the implant. This would be coded D4245, apically positioned flap. In most instances, only the D6011 would be used, but if you do perform both procedures you may use both codes to describe what has been done. In many cases, a carrier will only cover the most inclusive code and may not cover both.

Q: I get confused as to the meaning of "site." Can you explain the differences between sites for teeth, implants, and edentulous areas?

It can be confusing because the term "site" means different things in different situations. There are three times a site applies when



submitting claims. The first is soft tissue grafting, which is straight forward. A single tooth is considered a site. Submit one code for each tooth.

When dealing with any procedure involving missing teeth, such as ridge augmentation, a site is considered an area of two tooth positions or less. If you are treating the mandibular posterior, for example, where teeth #29-32 previously were, then this would be submitted as two sites and thus two codes.

Osseous defects are the most confusing. Simplified, if there is a defect on only one tooth then that is a site and one code is submitted. If one defect affects two adjoining teeth, communicating, then this is also a single site and one code is used. Osseous defects on adjacent teeth that cannot be probed from one defect to the other (a section of bone is between the defects) would be two sites, and two codes would be appropriate.

This is further explained at the beginning of the Periodontics category of the CDT.

Implants are not considered by "site." Implant codes for treatment of peri-implantitis or mucositis are submitted per implant.



Confused, conflicted and controversial views were prevalent on the role of Primary and Secondary Trauma from Occlusion (TFO) and Progressive Pathologic Tooth Mobility (PPTM).

On Friday afternoon, September 21, 1984, I presented a paper at the 70th Annual Meeting entitled "The Argument Against Splinting Using Hypermobile Teeth in the case of Zander, H. A., Polson, A. M. & Heijl, L.C. vs Ante, I. H. My lecture took the format of a mock trial in which the periodontist-attendees participated in the role of jury members to hear and judge the scientific evidence against treating hopelessly involved teeth.

I stay actively involved with other practicing periodontists by my years of Fellowship in the American Academy of Dental Science (founded in Cambridge, MA in 1867) and the American College of Dentists (FACD). I also use Google Scholar to read PDFs on the most current science studies of the NLRP3 Inflammasome, first discovered in 2002, review the studies reported in the *Journal of the American Dental Association* and the *Journal of Periodontology* and many others, and attend AAP Town Hall Meetings with our District Trustees.

Coming this Summer: Global Consensus on Innovation in Oral Reconstructive Medicine

In a landmark collaboration, the American Academy of Periodontology (AAP), the Osteology Foundation (OF), and the Spanish Society of Periodontology (SEPA) are joining forces to host a global consensus workshop on new technologies in oral reconstructive medicine. Taking place near Madrid in September 2025, this high-level meeting will bring together world-renowned experts to explore advancements in scaffolds, biologics, and personalized regenerative strategies. The outcome: five systematic reviews and three consensus reports to be published in a special issue of the *Journal of Periodontology* in 2026.

Stay tuned for insights from this international initiative driving the future of oral reconstruction, starting with a presentation of the initial findings at the 2025 Annual Meeting in Toronto!

Coming in 2026: AAP Launches Best Evidence Consensus on Prevention of Peri-Implant Diseases

Building on the success of the 2024 AAP/ AO Consensus Conference on Peri-Implant Diseases, the AAP is proud to announce its next Best Evidence Consensus (BEC), focused on prevention strategies for peri-implant diseases. Led by co-chairs Drs. Gustavo Avila-Ortiz and Purnima Kumar, this invitation-only meeting of experts will address a critical need: how to prevent the onset, progression, and recurrence of peri-implant conditions.

Stay tuned as the AAP takes the next step in advancing patient care and implant success through prevention. Look for publication of the proceedings, including systematic reviews, a consensus report, and appropriate use criteria (AUC) in the *Journal of Periodontology* in late 2026.



What the Co-Chairs Are Saying: "The central theme of the upcoming AAP Best Evidence Consensus (BEC) is Prevention of Peri-implant Diseases. As periodontists, we are finely attuned to the concept of disease prevention and recognize its importance. However, given the high prevalence of peri-implant mucositis and peri-implantitis, we have to address disease prevention even before placing the implant (primordial prevention) and continue to address it even after resolution of peri-implantitis (primary and secondary prevention). A series of comprehensive reviews related to risk factors for peri-implant diseases and risk-informed primordial, primary and secondary prevention strategies will form the foundation for the BEC in-person deliberations, scheduled for Spring 2026. We are honored to lead this initiative and are deeply grateful to collaborate with a distinguished panel of global experts from both academia and private practice settings. This collective effort aims to produce practical, evidence-based resources to support clinicians in delivering optimal care to patients with dental implants. In addition to the review articles and the consensus overview, we envision a key outcome: the development of an interactive tool designed to assist in clinical decision-making throughout the continuum of care for implant patients."

AO/AAP Consensus- Co-Chair Interview

In this special feature, we sit down with Dr. Hom-Lay Wang and Dr. Paul Rosen, Co-Chairs of the AO/AAP Consensus Workshop on the Prevention and Management of Peri-Implant Diseases and Conditions, as they share the origins, goals, and key takeaways from this important collaborative effort.





Dr. Paul Rosen,Workshop Co-Chair

To start, can you tell us where the idea for this consensus workshop originated?

The idea for this consensus workshop originated from Dr. Wang, who served as both the President of the Academy of Osseointegration (AO) and as the Chair of the AAP's Peri-Implant Diseases and Conditions Workgroup. During a strategic planning meeting, peri-implant diseases were identified as a growing concern and a topic of high relevance to both AAP and AO members. The realization that a joint effort could more effectively address this issue and benefit both memberships led to this collaborative initiative.

What inspired this collaboration, and why was this topic selected?

Peri-implant diseases are a significant and evolving clinical challenge. With Dr. Wang's leadership roles in both organizations, a natural connection was formed. The goal was to combine the resources and expertise of AAP and AO to develop clear, evidence-based guidance on managing periimplant conditions. Given the growing prevalence of implants and the complexity of related complications, this topic was ideal for a joint consensus workshop. The concept of collaborating on this topic was brought up at a Zoom meeting of the AAP's peri-implantitis workgroup aimed at identifying potential initiatives on this subject. Dr. Rosen was at first a bit reticent as the AAP has typically pursued projects like this through the Best Evidence Consensus model. However, he quickly realized that by collaborating with the AO, this would bring in more stakeholders such as oral surgeons, prosthodontists, and restorative dentists who would provide a much broader perspective to the topic. Most other groups/

organizations that have looked at the issues of dental implant complications have done so with the limited perspective of a single specialty.

By working together, we could address this multifactorial condition from a variety of perspectives. The collaboration allowed us to create a more unified and comprehensive clinical approach grounded in the best available science while filling in any gaps with a wide diversity of expert opinions.

What value did each organization bring to the table, and how did this strengthen the process?

The AAP contributed substantive expertise in the biological basis and surgical management of peri-implant diseases. The AO, with its diverse membership—including prosthodontists, oral and maxillofacial surgeons, and general dentists—added critical insights into prosthetic design, occlusion, restorative techniques, materials, and surgical considerations. By integrating these complementary perspectives, the consensus recommendations became more robust, practical, and impactful for clinicians.

Without giving too much away before the papers are published in June, can you share any general themes or insights that emerged during the consensus workshop?

The consensus, to be published in June 2025, includes systematic reviews and practical guidance. Two central themes emerged:

- Risk Factors, Indicators, and Determinants of Peri-Implantitis
- 2. Management of Peri-Implantitis and Other Implant-Related Complications

In addition, a summary paper titled AO/AAP Consensus on Prevention and Management of Peri-Implant Diseases and Conditions: Summary Report will offer clinicians clear, actionable takeaways and treatment algorithms to guide patient care.

What stood out to you or sparked the most engagement among the participants?

The depth and breadth of discussion were exceptional. Experts contributed insights from both clinical experience and cutting-edge research. Particularly engaging topics included identifying risk factors—local, systemic, surgical, and soft tissue phenotype—and approaches for decontaminating implant surfaces. There was also considerable interest in evaluating surgical options, such as resective and reconstructive procedures using either submerged or non-submerged methods. Moreover, the workshop underscored the inflammatory nature of the biologic complications and ways in which clinicians might approach both prevention and treatment that had received limited attention.

What are the most important messages or implications that AAP members and clinicians should take away from this work?

AAP members and clinicians should understand the complex interplay of factors that contribute to peri-implant diseases—including prosthetic design, occlusion, medical conditions, and soft tissue phenotype. The consensus outlines effective

methods for implant surface decontamination and current best practices for treating both peri-implant mucositis and peri-implantitis. Decision-making tools, including treatment flowcharts, are provided to assist clinicians in managing these conditions effectively in daily practice.

Do you think these findings will influence or change current clinical practice in periodontology and implant dentistry? If so, how?

Absolutely. This consensus is expected to have a significant impact on clinical practice. By focusing on the identification and management of risk factors and by offering decision trees for clinical treatment, it provides accessible tools—such as flowcharts and evidence-based guidelines—that clinicians can readily apply. These resources will enhance diagnostic accuracy, improve treatment planning, and ultimately lead to better patient outcomes and long-term implant success.

What's next? Are there plans to build on this consensus with future research?

Yes, the consensus has highlighted several areas that warrant further study. Future research directions include assessing the impact of maintenance protocols, understanding the role of occlusion in peri-implant disease progression, and optimizing patient education for both personal and professional hygiene around implants. Additional consensus workshops and follow-up studies are already in development, with strong support from the AAP, to continue advancing the science and practice surrounding peri-implant disease prevention and management.

The proceedings from the AO/AAP Consensus on Prevention and Management of Peri-Implant Diseases and Conditions are now available online at perio.org. Look for the consensus report and the review papers from the Risk Factors, Indicators, and Determinants of Peri-Implantitis group in the June print issue of the Journal of Periodontology.

ABP DIPLOMATE INTERVIEW



Jeffrey A. Rossmann, DDS, MSDirector of Examinations

How has Board certification shaped your career in Periodontics?

My initial motivation to become board certified came during my residency program at the U.S. Army Institute of Dental Research, Walter Reed Army Medical Center, Washington, DC. Board certification was expected of us to be competitive for promotion in the Army Dental Corps. At first that was enough motivation and personal fulfillment. However, once board certified, this opened opportunities I could never anticipate at the time, such as academic opportunities after my military service and serving as an Examiner for the ABP. The result has been a wonderful career including 25 years as a faculty member at Baylor/Texas A&M School of Dentistry, serving the ABP for 18 years, culminating in my current


position as Director of Examinations. Every position I've held in periodontics was contingent on my being a Diplomate of the ABP, including my private practice in the Dallas area for 25 years with my business partner and good friend, Mike McQuade. I cannot overstate how critical that decision to become board certified affected my success in all those endeavors.

The Director of Examinations provides substantive guidance to the ABP Board of Directors on examination policy and best practices, oversees the examination process, and supports candidates throughout the process. How did you come to serve in this role and when did you start in this position?

My last year of a six-year term as a Director on the ABP Board was 2017. The Executive Director, Kent Palcanis, announced his retirement effective 2018 and the Board of Directors determined it was time to take a new direction for future growth of the Board and established the position of Director of Examinations. This newly developed position would separate the duties from the Executive Director's position and concentrate on the process of certification and oversight. I was elected to that new position in 2018, and it has evolved into the description mentioned above.

During your time as Director of Examinations, what challenges and opportunities did you encounter?

The position of Director of Examinations is all about relationships. Establishing trust with the candidates and providing them the confidence to challenge the certification process, knowing it will be fair and equitable for all. It is also important to establish a solid



relationship with the Examiners, so they are motivated to participate in an arduous week of examinations and proud to have the distinction that comes with being an Examiner. I am happy to report that our examiners overwhelmingly feel this duty is the culmination of their professional careers.

The biggest challenge came in 2020 with the advent of the COVID pandemic. It was no longer feasible to plan an in-person oral examination for the 200 candidates challenging board certification that year and bring 50 examiners together to administer the exam. We attempted to develop an alternative online (virtual) examination maintaining the same criteria and standards we've upheld in past examinations; however, the issues of security, internet connectivity, confidentiality, etc. became overwhelming. In the end, we did not hold an oral examination in 2020. and the Board gave each candidate an additional year of eligibility. This led to the next challenge for 2021, which was adding approximately 20 new examiners to the active pool to administer a calibrated in-person exam. We met those challenges and successfully tested 300 candidates in 2021.


The opportunities have included upgrading the examination process to incorporate the latest technology. This can best be described as taking a completely analog paper examination using test

booklets and paper score sheets in 2021 to a fully digital iPad examination in 2023, as well as moving to a testing center in 2021 in Raleigh, NC that is designed specifically for our needs. We now can accommodate 250 or more candidates each year in a state-of-the-art facility, giving five days of examinations and utilizing 55 examiners annually.

Do you have any advice for those considering pursuing Board certification?

You will never regret becoming board certified in Periodontology and Dental Implant Surgery. It has become the standard of care for many third-parties of interest, as well as your referring doctors and patients. Although it is always a personal achievement for which you will take pride in accomplishing, it is now considered the expectation by our professional peers and patients. It is never too late in your career to consider challenging the certification process and I would encourage everyone in Periodontics to do so. Board certification is the highest standard to which we hold the profession and you owe it to yourself to become a Diplomate of the American Board of Periodontology.

AAP FOUNDATION

Kyle Gorden became executive director of the AAP Foundation in January. Sarah VanAmburg, director of development programs, sat down with him to discuss his background, what he has learned about the Foundation so far, and his vision for its future.

Profile of **Kyle Gorden**

SV: How did you come to the American Academy of **Periodontology Foundation?**

KG: My entire career has been in the advancement profession – for arts organizations and in several alumni relations and development roles at my alma mater, the University of Chicago. I spent the last decade as a consultant for nonprofits of all types, from major universities to small social service organizations. Two in particular - the Urban Land Institute Foundation and the Association of Public and Land Grant Universities – introduced me to associations and what I see as their largely untapped potential for philanthropic impact. Since most health-related associations are headquartered in the Chicago area – where I have spent most of my adult life – I decided to keep an eye out for opportunities in the field.

SV: As a newcomer to the specialty, what are your impressions of periodontology and the AAP Foundation?

KG: It's a remarkable time to be joining the Foundation, in its 35th anniversary year. I'm incredibly fortunate to be inheriting an ambitious fundraising campaign that has already launched with great enthusiasm, a rush of initial support, and a strong volunteer leadership team in place. The number of AAP members who have already stepped up with



unrestricted gifts is a testament to the trust that the community has in this organization, reflecting our long history of support for periodontal education. More than 350 periodontists have received at least one award from the Foundation, and every one that I've spoken to has told me how dramatically it impacted the course of their career, including those with relatively modest monetary awards. The support from the AAP itself and from the American Board of Periodontology just confirms the strength of the mutually beneficial relationships between all three organizations and their shared constituencies.

SV: What are the Foundation's fundraising priorities in the near term?

KG: The Foundation for the Future campaign is focused on unrestricted gifts, so that's our top priority. There are also numerous opportunities for donors to support existing award programs without dedicated funding sources, including some of our most prominent awards. We also welcome inquiries from donors with more ambitious ideas to create new programs, although we'll ask them to consider making portions of their gifts unrestricted to ensure that we have the capability to execute those new programs.

SV: What about in the longer term? Where do you see the Foundation in five or ten years?

KG: Most philanthropic dollars in the biomedical field fund research. While the Foundation supports research by recognizing and awarding those who perform it, it hasn't historically made many investments that fund direct research costs. There's a real gap in the research funding pipeline between basic science and clinical trials, what's

called "translational" research, and I think that's an area where the Foundation's donors can have a major impact in the coming years.

SV: Where do you see the biggest opportunities for fundraising growth?

KG: The Foundation was established by the Academy to assist periodontists in realizing their ambitions to positively impact the specialty through philanthropy. We're renewing our focus on planned or strategic giving — leveraging opportunities for gifts that advance our mission while also offering benefits to the donor. Planned giving isn't just about bequests—it turns out that many of the Foundation's largest gifts were made by donors in their 50s and 60s. This year we're renaming our annual planned giving event at the Annual Meeting the Practice Transition, Retirement, and Estate Planning Breakfast, to reflect that.

SV: The Foundation's mission is "to advance the specialty of periodontology and dental implant surgery through advocacy, research, and education." You've spoken about the education and research components—how do we achieve the advocacy part?

KG: In a way, the advocacy component is the most interesting. Advocacy isn't just about lobbying and, as a 501(c)(3) charitable organization, there are restrictions on how much we can do to advocate for government policies. I see our role as providing tools for periodontists to raise awareness in their own communities: of periodontal and peri-implant diseases, of the importance of treating them, and of the dedicated specialists who can help. This is something the Foundation has done for years with programs like PerioDash, although they haven't always been positioned in that way. This year we're working with our board and volunteers to better articulate that work and to identify new ways to pursue that critical component of our mission.

PerioDash: an **Advocacy** and **Teambuilding** Toolkit for Private Practices

For the last decade, PerioDash has been bringing periodontists and supporters together—in person and remotely—through a virtual run focused on raising awareness of the AAP Foundation and its mission. As we enter the program's 11th year, we're excited to reposition the popular program as an advocacy initiative and expand its reach among private periodontal practices looking to grow their profiles and expand their local connections.

While the virtual run remains the core of PerioDash, we're encouraging practices to use it as a platform to bolster referral networks and to educate patients and the public about periodontal and peri-implant diseases, the importance of treating them, and the dedicated specialists who can help.

Beyond outreach, private practices have also found that PerioDash helps bring their teams together. Staff, partners, and families (babies and pets included) came out to set up, run, and celebrate together. That sense of shared purpose and camaraderie can carry back into the practice, lifting morale and reinforcing a culture of enthusiasm, collaboration, and care.

This new direction builds on the Foundation's commitment to supporting periodontists by empowering practices to lead local advocacy efforts. Whether you've been part of PerioDash
